

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to balletetudes.com, and Ballet Etudes and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ballet Etudes include balletetudes.com and BE. The BE website is a news and information site. By using the BE website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, BE may collect personally identifiable information, such as your:
